Analysis on JRA1 tasks effort used versus plan

DS: I update the excel file tracking JRA1 tasks effort used versus plan with QR11 data: <u>https://indico.egi.eu/indico/materialDisplay.py?contribId=7&materialId=0&confId=1344</u>

DS: I highlighted in the spreadsheet Partners' over/under spending (over > 120%; under < 75%)

Critical Issues:

- TJRA1.2:
 - CESGA over spending: 144%
 - GRNET under spending: 54%
- TJRA1.4 under spending 54%:
 - CESGA under spending: 33%
 - INFN under spending: 21%
 - STFC under spending: 72%

DS: CESGA should report in TJRA1.4 in the next quarters reducing his activity in TJRA1.2 in the next quarters. This is coherent with the CESCA plans for the next quarters.

ID: Ok

DS: I'll contact GRNET, INFN and STFC to try to fix the other issues.

Updating service type names in GOCDB, impact and devising a strategy to update Slides uploaded in indico:

Requirement:

- Ease integration with other systems + interoperability.
- An EMI aim is to start migration for GLUE2 compliance ASAP: https://ggus.eu/ws/ticket info.php?ticket=91632
- Document a process for such requests on EGI wiki (10~20 other potential names)

Impact:

- Some dependent tools maintain history + stats against current types (e.g. SAM).
- Other systems? E.g. WLCG

Options:

- 1. <u>Reject and wait for new GLUE2 XML PI methods</u> that *will* use the GLUE2 service type names (GOCDB will do internal mapping).
 - Current PI service types remain unchanged

- Inconsistent 2 SE type names for same service
- 2. Add 'org.nordugrid.arex' and phase out 'ARC-CE'
 - Deal with other SE change requests in similar way.
- 3. Update all 'ARC-CE' services in GOCDB to 'org.nordugrid.arex'
 - Probably not an option due to SAM + other dependent tools

PF: The third option is not feasible for SAM. The other 2 options are fine.

DM: Considering both the first and second option for SAM are fine, I prefer to follow the second.

DS: I agree, we can follow the second option.

DS: Updating service type names in GOCDB has impact only for SAM. Then, we can proceed to implement this solution.

DS: I'll create a wiki page describing the procedure to update a service type name. David and Paloma should review the wiki page.

Scoping Enhancements and Management Interface

- A) Scoping Enhancements: Extend the current 'EGI' and 'Local' data scoping logic to introduce multiple, non-exclusive scope tags to encourage other projects to host their data within a single GOCDB instance ('EUDAT' 'PRACE').
 - Current 'Local' and 'EGI' scopes are mutually exclusive; a site/service can only be tagged with a single scope.
 - Enhancements will allow a single object, such as a site, service, or service group (virtualsite) to be tagged by multiple projects without duplication of information.
 - Extend current PI 'scope' parameter to support a comma-separated list of requested scopes, e.g:
 - A) <u>https://goc.egi.eu/gocdbpi/public/?method=get_site&scope=EGI,EUDAT,UK_NES</u>
 - B) <u>https://goc.egi.eu/gocdbpi/public/?method=get_service_endpoint&scope=EGI,UK_NES</u>
 - Scoping Rule: Options for a 'Service.Scope' value will be limited to the parent 'Site.Scope' values. This way, an SE can't define a scope that is not already defined by its parent site.

B) Provide a supporting GOCDB management interface to simplify daily operational/admin tasks.

- Many administrative tasks are performed directly on the database using scripts
- Admin interface will speed-up and simplify such tasks (e.g. for new GOCDB admins)
- Decrease the likelihood of introducing error
- Starts mid-March + build on v5 release.
- New developer in place for 6mths.

Regional Apel Server:

- The New EMI 3 APEL Client can be configured to send Summary Records to either the central APEL server or a regional APEL server.
- Communication between clients and servers is via the EGI Message Broker network using the APEL SSM package. Where the messages are destined for is controlled by the queue which is set in the SSM configuration.
- EMI 3 Release date is 7th March, 2013
- Regional APEL server comprises:
 - MySQL database
 - apel-lib, apel-server and apel-ssm packages
 - Packages available on github and documentation for installing a test setup available now
- Test configuration must include one system running EMI 3 APEL Client and one running Regional APEL Server
- Data from existing APEL Client can be used for testing -test Central APEL Server available for Regional APEL Server testing now.
- APEL team need to coordinate with test sites so contact <u>apel-admins@stfc.ac.uk</u> for documentation and to start testing.
- Regional APEL Server in production planned for April, 2013.

Regional Accounting Portal:

- The Regional Portal will be distributed as a preconfigured, ready-for-use VM.
- Updates will be published via a code repository, improving solution time and enabling local branches with regional specific code.

- NGI staff only required to do small administration tasks, like updating the code or configuration.
- Portal staff will assist NGI staff and have a copy of their installation in hand to debug and propagate fixes.
- Regional version will display local sites and federations, so some views (e.g. OSG) and reports will be removed. Each VM will be tested against the corresponding regional APEL server.
- VM deployment required a separate VM instance from the APEL repository and appropriate VM managing software.
- Production versions expected for end May-June 2013.

DS: Both services must be in production by the next review (end of June). End May/June deadline for the regional accounting portal has to be considered as an hard deadline. I suggest to start integration tests (regional accounting repo + regional accounting portal) ASAP.

ID: Put in production the regional accounting portal by the deadline should be easy.

The outcome of the WG will be a list of probes that SAM should integrate. We expect this list to be finalized by mid-March. For probes that are missing or have other issues WG should propose actions to take. The list of current issues has been sent to Marcin already.

The list of issues has been also sent to EMI and the testing page has been updated to reflect the current status (<u>https://twiki.cern.ch/twiki/bin/view/EMI/NagiosServerEMITestbed0022012</u>).

Since then we have discovered additional 2 bugs in ARC probes - those will be added to the page. We're waiting on EMI to give us a schedule of EMI 2 updates where those issues will be fixed. EMI 2 update containing at least the critical fixes is needed before SAM can provide an integrated release.
