Analysis on JRA1 tasks effort used versus plan

Excel file with the JRA1 tasks effort used versus plan at the end of PY4 uploaded in agenda.

DS: Major issues highlighted in excel file: (1) red - over reporting (more than 120%); (2) yellow - under reporting (less than 70%):

- TJRA1.2:
 - CESGA aggregate (PY1+PY2+PY3) over-reporting (136%). Mitigation: CESGA will report mainly in TJRA1.4 during PY4;
 - GRNET aggregate (PY1+PY2+PY3) under-reporting (55%). Mitigation: GRNET should use 7.1 PM during PY4 to recover the under-reporting;
- TJRA1.4 Task under reporting in PY3 (68%) and aggregate (PY1+PY2+PY3: 60%):
 - INFN under reporting in PY3 (45%) and aggregate (PY1+PY2+PY3: 30%). DS discussed with Luciano Gaido (LG) about this issue. LG declared that more effort will be used during PY4;
 - CESGA aggregate (PY1+PY2+PY3) under-reporting (46%). Mitigation: CESGA will dedicated PY4 to TJRA1.4 activity.
- TJRA1.5 The task ended this year with the 99% of resources used: Issue fixed.

AP: STFC will provide more effort during PY4 to reduce the TJRA1.4 under reporting.

Action: DS will contact GRNET to find a mitigation for the TJRA1.2 under-reporting.

New Accounting Features (Ivan Diaz Alvarez)

Emir: Exist a UserDN probe issue. The accounting portal publishes UNKNOWN results for a while (about 1 hour).

ID: it depends on internal mechanism to update UserDN data. We should change this internal mechanism to remove this period without no UserDN data published. We could be have an update in about 1 month (Action on Ivan).

DS: Could you, please update us about the status of parallel jobs and storage accounting?

AP: With EMI-3 parallel jobs should be accounted, however parallel jobs are not so frequent. We should find some sites willing to test. We could contact the MPI VT to do it (Enol Fernandez and Alvaro Simon).

DS: summarizing we'll select some sites to test parallel jobs accounting and verify if the parallel jobs accounting data will be properly collected by APEL repo. AP will contact Enol and Alvaro (MPI VT) to understand if they could help us during the testing phase (**Action on Alison**).

ID: I agree, it's a legacy component

Action on ID: Remove the tickets part of the metrics portal.

EI: Last OMB we described how the transaction to update-22 works. In SAM Update-22 we changed the name of some metrics and some of this metrics are part of the Ops Portal. From the SAM prospective is resolved by mapping done in the central instance enabling old and new sites to coexist for a while and the availability is not affected. For the metrics with the name changed we have to do some operations test (no procedure defined). The ops portal should also to keep the old and new names for a while. It should be done at the same time we start the staged rollout (assuming we'll use the prod instance for the SR). We have to decide what do with the already opened ticket.
