MK: I'm going to start an analysis about service with the production flag set to true and the monitoring flag set to false to understand the impact to not allow this configuration anymore.

SP: we do not have a field to add the flavor information to the usage record. Maybe, a lookup table to map accounting info to flavor is needed.

DS: can we now move the cloud accounting views to the production instance of the accounting portal?

SP: we can do it when we resolve the issue related to how to identify Fedcloud production site

DS: what kind of information are currently stored in the VMUUID and ImageId fields of the cloud accounting usage record?

SP: I will check the data and I will inform you

Action on SP: investigate on which data are currently stored in the VMUUID and ImageId fields for each Cloud management framework support in the EGI FedCloud

DS: about the accounting of the users behind a robot certificate, we verified that to deploy the designed solution we need a slight but coordinate update of three products, Cream, Blah and APEL. Can you take care of that?

SP: I think it is better to remove GPGPU accounting activity from the plan and postpone it to EGI-Engage when GPGPU will be in a more mature state.

DS: removing GPGPU should be agreed by AMB since this activity is in the DoW.

SP: It is only a proposal. I would like to discuss with the GPGPU working group to understand if there is a way to go ahead.

MK: I will raise this issue to Peter Solagna since he is following the GPGPU activity.

Action on MK: discuss with Peter about the current status of the GPGPU activity to understand if we already have a way to develop a GPGPU accounting prototype

DS: What is the status of transient cloud storage accounting?

SP: I had a discussion during the conference in Amsterdam about CDMI

DS: I suggest to have a look on the block storage solution, it is already working

SP: Ok thanks.

DS: Can we move the MPI portal views to the production instance not yet the repository starts to send data to the portal?

SP: In my understanding, after we starts to send data to the portal and after we collect a relevant number of data, we should get a feedback from the users to understand if the metrics collected are fine. We will move to production only after this phase

DS: About cloud accounting and the long running VMs, how does the accounting work now?

SP: Currently we collected information on the repository when the VM is started, suspended and completed. But we send information to the portal only when the VM is stopped.

DS: If I started a machine April and this machine is still started, I currently do not have any information of this VM in the portal, is it right?

SP: we have the information in the repository but not in the portal.

DS: in my opinion this is something that should be changed. We have many scenarios with long running VMs.

SP: we are discussing about that on the FedCloud TF

Action on SP: discuss with the FedCloud TF to how to change the accounting to take into account the long running VMs.
