- Orchestration as part of laaS Federated Access Tools allowing for easier moving of applications from different providers
 - all using proprietary language to describe the infrastructure, TOSCA is the standard working for better support of that in all tools
 - o generally all tools well documented and feature-wise similar

- IM can be used on very bare VMs, can deploy the same infrastructure on public Clouds with only minor changes, wide range of providers supported, configuration done with Ansible, used in production within EGI
- Terraform used in the commercial world, works well with e.g. Amazon Cloud, not only laaS also PaaS (e.g. Heroku), will give a preview of execution plan before actual submit, but configurations not easily portable.
- Occopus supporting many cloud providers! Can also specify monitoring with error detection and recovery. Scaling can be triggered.
- Plan for official EGI instance of IM: currently under discussion, wiki includes information on how to access current instance
- B2STAGE install status: test instance successfully installed (just using Docker, small iRODS capacity), but production state connecting to outside iRODS gives still errors.
 - o Contact to the developers needed, e.g. chat or file issue on gitHub
 - Peter officially on vacation from tomorrow

- ICOS decided to no longer test OneData.
 - Setup with some large files works nicely
 - still problems with small files for Ute (worked for developers?). stops at some time and EGI DataHub not responding any more
 - CYFRONET needing more infrastructure setup (Docker configuration, ..) info to replicate?, they could test directly on the same VMs
- OneData not needed to solve ICOS use case problem, input data is copied once to VMs (introducing overhead of copying data, though, but could also mount any network system), output is very small
- Regarding EGI Pay for Use information, this model is new to EGI but some information is available here: https://wiki.egi.eu/wiki/VT_EGI_Pay-for-Use_PoC and https://wiki.egi.eu/wiki/EGI_Pay-for-Use_PoC:Service/Price_Overview. Sy Holsinger is the best person to talk to about this we'll see if he can attend the next ICOS EGI/EUDAT meeting. There are no examples for architectures yet, no SLA's in use for using the resources on a pay for use basis.
