## **ITEMS OF BUSINESS**

#### Minutes of 27 October

DC asks for clarification on the scenario work package assignments. MT replies that the scenario leaders are coordinating the work that is undertaken by the Task Force participants to accomplish the pertinent scenario and that in principal all resource providers are expected to actively participate and contribute to all scenario work packages.

DC further asks whether it is okay to source in more persons from CERN in order to facilitate and take on the work necessary for monitoring in a federated Clouds landscape (Scenario 5). MT confirms sourcing in technical experts for DC to bring into the Task Force for Scenario 5 (see Action 02/04).

## Affiliation and Deputies in the member list

MD describes the reasons behind assigning representatives and deputies to have a consolidated and permanent list of contributors that take part in the Task Force. MD further points out that this list is not complete and needs review (see Action 03/04).

## **Review inventory matrix**

MT reviews the inventory matrices contributed by Resource Providers and Technology Providers. He further underscores the importance of the information provided so that scenario leaders and participants can start agreeing on a baseline of technology that is required to accomplish the respective goal. MT further identifies SARA, KTH, MPI and CloudSigma as Resource Providers that are still required to provide the requested information as soon as possible. MD further numerates the corresponding Actions: 07/02 (KTH), 08/02 (SARA), 04/03 (CloudSigma) and 05/03 (Max-Planck-Institut).

#### Federated AAI

#### **Authentication: X.509 certificates**

The group discusses how to proceed with a common Authentication infrastructure. CL states that StratusLab supports both X.509 certificates and username/password credentials. TS adds that Cyfronet currently does not support X.509 certificates for user authentication, but is prepared to add this functionality as required, but that this would need time. No further contributions to this topic were provided.







#### **Authorisation infrastructure**

CL indicates that StratusLab is currently using EMI Trustmanager to provide Authorisation for users; he further indicates that StratusLab and EMI are exploring options for an Argus plugin to integrate Cloud infrastructure with existing Grid infrastructure. However, StratusLab would not provide such plugin, but it will be on EMI to write an integration module, CL clarifies further.

#### **Security audits**

The call participants discussed security audits; the current understanding of security audits points towards assurance of the business processes in a B2B model and bilateral agreements between Resource Providers. As such, MD states, they are out of scope for this Task Force and need to be developed through other means. ZS originally requested this topic to be discussed, but was unable to join the call, so any further discussion is postponed until ZS joins the call, or further clarifies offline (see Action 04/04). MT agrees and further states that EGI is attempting to develop and deploy a hybrid cloud model where security audits pertain to the Resource Providers rather the Task Force's remit.

### Work group scenario 1 report

MD explains the principles how accomplishing Scenario 1 is planned. The next concrete steps are laid out in the scenario-specific action list.

MD polls for current status of Resource Providers whether they are in the position to provide WeNMR users provided by AB with accounts at their Cloud infrastructure to start using their resources. MT reports for Oxford that they the services are currently offline. More information about the outage duration and nature should be available in the afternoon. SK reports for TCD that they are unable to accept users this week, and asks for the list of specific users. SK further clarifies that a meeting tomorrow Wednesday 5 October should clarify the issues around user registration and that more information should be available by then. TS reports similar problems for Cyfronet, and further informs the call participants that in the current process users of Cyfronet Cloud infrastructure are required to be members of the Polish NGI. TS continues that he is investigating whether this constraint may be lifted for the Task Force test-bed purposes.

## Work group scenario 2 report

Discussing this scenario is postponed to a later point in time for the scenario coordinator, MH, is not present at the call.
